Meeting of the 2014 Polish Dance Platform Artistic Commission – minutes

Based on the Rules and Regulations of the Polish Dance Platform (PPT), the Artistic Commission of the Polish Dance Platform 2014 met at the Institute of Music and Dance in Warsaw on 8–9 September 2014 to select performances to be presented at the 2014 Polish Dance Platform.

The commission chose Jadwiga Grabowska (Majewska) to chair the meeting, and Izabela Szymańska to act as the commission's secretary.

The commission elected to make decisions by consensual voting.

The commission chosen the following selection criteria:

- high artistic merit;
- technical skill and performative maturity of dancers;
- artistic concept;
- individual approach to the topic;
- originality of choreographic devices;
- skilful incorporation of different means of expression;
- originality in international context;

Justification:

Based on the criteria listed above and with all its members in attendance, the Artistic Commission chose by consensus 13 out of 95 performances submitted to be presented at the Polish Dance Platform on 7–9 November 2014 in Lublin, Poland. The commission believes that the pieces selected will make up a diverse and representative landscape of the Polish dance scene. The performances are characterised by high artistic merit as well as

commendable technical ability and peformative maturity of dancers. Their creators have skilfully incorporated different means of expression and employed original choreographic devices, while looking for a distinctive language to give their artistic concepts an individual expression. The commission took into account the submissions' originality as compared to other Polish and international works. The pieces display a novel approach to the art of dance, relations with the audience, theatricality, choreography, and body work. The artists have raised intimate and social topics, both current and universal.
